VII. Agenda Items

1. Consider a Resolution urging President Trump to honor his campaign promises to the Haitian American community by extending Haiti's temporary protected status designation for 18 months beyond January 22, 2018.

BACKGROUND AND SUMMARY: According to Councilman Antoine: The Trump administration will announce between Nov. 6th and Nov. 23rd if it will end or extend Temporary Protected Status (TPS) for 58,000 Haitians. Termination would be catastrophic. The issue affects 58,000 non-criminal Haitians who have lived in the U.S. for 7.5 to 20 years, i.e. since before the 2010 earthquake. Many have US-born children who shouldn't have to choose between their birthright as Americans and their children.

2. Consider a Resolution by the City council of the City of Forest Park authorizing the Mayor to sign a Master Lease Agreement transferring an 80' x 120' parcel of land, at 5230 Jones Rd, to the Development Authority of the City of Forest Park for the purpose of leasing said property to Towercom v. LLC; to provide an effective date; and for other purposes.

BACKGROUND AND SUMMARY: Towercom V. LLC has expressed interest in having an option to lease an 80' x 120' parcel of land at 5230 Jones Road from the City of Forest Park Development Authority. If executed, the purpose of this lease would be to construct a 175' communications monopole and would consist of an initial five (5) year period with an option to renew for nine (9) additional five (5) year terms. In consideration for an initial 12-month option to lease, Towercom V. LLC has agreed to pay the City of Forest Park Development Authority \$2,500.00. Furthermore, Towercom V. LLC has the option to extend this lease option for two (2) additional 12-month periods; each requiring an additional payment of \$1,000.00.

If the lease option is executed, Towercom V. LLC agrees to pay all costs associated with constructing and maintaining said monopole. In lieu of paying rent to the City of Forest Park Development Authority, on the leased property, Towercom V. LLC. has agreed to share 50% of all revenue received from any wireless carrier that co-locates on the monopole.

Due to the City of Forest Park's inability to enter into multi-year agreements, it is necessary to transfer said real property through a master lease agreement between the City of Forest Park and the City of Forest Park Development Authority. This master lease agreement will run concurrently with the option agreement and ground lease and terminate when and if either of these agreements is terminated. The City of Forest Park will serve as the agent for purposes of administration of the option agreement and ground lease and receipt of option consideration and rent payments.

3. Consider a Resolution authorizing the Mayor to execute the contract with Four Points Construction for Renovation Improvements at Public Works.

BACKGROUND AND SUMMARY: The project is the renovation of the current Public Works building located at 5230 Jones Road. Originally built in the 1960's, the facility is a 13,000 square foot structure with many of the original systems still in place. Since the structural integrity of the building is intact, the project will consist of a comprehensive interior renovation to include the interior walls, offices, conference room, lunch room, locker room, restrooms, and

server room. Also included will be the replacement of the original windows and the upgrade of the roofing system. Finally, the project will upgrade and replace the mechanical, electrical, and plumbing systems to meet current code requirements, improve energy efficiency, and meet current and future needs of the department. After an in depth interview and selection process, the lowest responsible and responsive bidder is Four Points Construction Inc. with a bid price of \$943,789.99.

- 5. Consider an Ordinance by the City Council of the City of Forest Park, Georgia, to appropriate funds for wage and salary increases for employees of the City; to provide an effective date; and for other purposes.

BACKGROUND AND SUMMARY: An increase is needed to the wages and salaries of City employees, to supplement for cost of living increases. The most recent increase was approved in January 2014. The City's General Fund reserve for fiscal year ending June 30, 2017, increased substantially, and is approximately the same as in 2014. The cash position of the City's General Fund is strong and also approximates the balance at the time of the most recent increase. The increases in both the reserve and cash position can be attributed to increase in revenues and reductions in Department budgets. These factors are expected to continue.

6. Consider a Resolution by the Mayor and Council of the City of Forest Park, Georgia establishing a one hundred eighty-three day moratorium on the enforcement of the assembly use provisions of the zoning code.

BACKGROUND AND SUMMARY: The Places of Assembly Ordinance was adopted by the Mayor and Council in February 2007 in an effort to maintain the safety and general welfare of the City of Forest Park and to establish a method of balancing retail development and other commercial uses as outlined in the City's Comprehensive Development Plan. The terms of the Places of Assembly Ordinance regulates the distance of certain uses through a distance measurement formula.
