Consider an Ordinance to amend the Charter of the City of Forest Park by revising Section 4.11 ("Chief Judge; Associate Judge") of Article IV ("Municipal Courts") therein; to provide for severability; to repeal conflicting ordinances; to provide an adoption date; to provide an effective date; and to provide for other lawful purposes.

**BACKGROUND AND SUMMARY:** House Bill 691 amended certain sections within Title 36 of the Official Code of Georgia relating to the appointment and removal of municipal court judges requiring the aforementioned amendments to city charter.

2. Consider an Ordinance to amend Chapter 5 ("Municipal Court") of article A ("General Provisions") of the Code of Ordinances, City of Forest Park, Georgia, by amending Sections 2-5-17, 2-5-18, 2-5-18.1, and 2-5-19; to provide for severability; to repeal conflicting ordinances; to provide an adoption date; to provide an effective date; and to provide for other lawful purposes.

**BACKGROUND AND SUMMARY:** Upon amendment of the city's Charter, changes must be made to the Code of Ordinances to ensure compliance with the City's Charter.

3. Consider a Resolution to establish compensation and frequency of payment of such compensation for the Chief, Associate and Judges Pro Tempore; to provide an effective date; and for other lawful purposes.

BACKGROUND AND SUMMARY: Reference Agenda Item #2.

4. Consider an Ordinance to amend the Code of Ordinances, City of Forest Park, Georgia, to establish a Department of Technology Services by amending Subsection A of Section 2-3-1 (Departments Established) in Article A (General Provisions) of Chapter 3 (Administration) in Title 2 (General Government) and by enacting Title 12 (Technology Services) and Chapter 1 (Department of Technology Services) in said Title; to provide for severability; to repeal conflicting ordinances; to provide an effective date; and for other lawful purposes.

**BACKGROUND AND SUMMARY:** City administration has become increasingly more dependent upon the use of information technology including, but not limited to, computers and data communication systems. The proposed ordinance creates a new Department of Technology Services operating under the direction of a newly created Technology Services Director position.

**BACKGROUND AND SUMMARY:** At some point in time in the past, some 19 parcels of real property in an otherwise residential zone (R-80, RM-85), were rezoned to General Commercial District (C-1). Over time, many of the businesses have closed and are vacant buildings and/or lots. The 2010-2030 Future Land Use Map adopted by the Mayor and Council and contained in the City's Comprehensive Plan, shows the entire study area as planned for residential use. The proposed rezonings are in compliance with the overall goal of the future land use plan outlined in the 2005-2025 Comprehensive Plan. Properties that are currently in compliance with the city's zoning regulations will be able to continue operating under the current zoning classification subject to the terms of non-conforming use ordinances.

8. Consider an Ordinance to amend Section 8-8-121 ("Establishment of Board of Appeals") of Article I ("Board of Zoning Appeals") of Chapter 8 ("Zoning") in Title 8 ("Planning and Development") of the Code of Ordinances, City of Forest Park, Georgia by repealing the current language in said Section in its entirety and enacting new regulations in lieu thereof; to provide for severability; to repeal conflicting ordinances; to provide an adoption date; to provide an effective date; and to provide for other lawful purposes.

**BACKGROUND AND SUMMARY:** In considering a member of the City Board of Zoning Appeals for another city board appointment, it became evident that the language in the current ordinance governing members of the Board of Zoning Appeals states that: "None of the members shall hold any other public office or position in the municipality, except that one member may also be a member of the planning commission." The purpose of this proposed ordinance would be to repeal the current language thus allowing members of the Board of Zoning Appeals to serve on any other boards.

Councilwoman Wells suggested naming 696 Main Street after Mr. Hartsfield. Mayor Lockhart stated that he wasn't sure that 696 Main Street is the right way to memorialize his services. Mayor Lockhart stated that he didn't know the right particular location but Mr. Hartsfield is well worth memorializing.

City Manager Report: 890 Conley Rd. Mr. Wiggins stated that the vacant and dilapidated Old Briarwood Forest Apartments located at 890 Conley Road will have legal notices posted on the property and a special lien placed against the property to address the nuisance conditions within the next 60 days. All the work and the cost associated with hiring our attorneys to act as a special prosecutor to get this issue addressed, we hope to recover the funds through sale of the property.

4666 Jonesboro Rd:

Mr. Wiggins stated that 4666 Jonesboro Road is the old coin operated laundromat which has been in a state of disrepair and may also be a collapse hazard at this point. The property was sold last week and as soon as we are able to locate the owner, we will be able to begin the abatement process if the owner doesn't come into immediate compliance.

FPHS PTSA:

Mr. Wiggins stated that the Forest Park High School PTSA is asking for gently used suits and dresses for their upcoming prom. They also have shirts for \$10. The membership to the Forest Park PTSA is \$10. Please support the PTSA. Mr. Wiggins stated that we will have membership forms at the next council meeting.

Drought Restrictions:

Mr. Wiggins stated that we are still in a Level 2 drought restriction. The water restrictions are still in place and we don't have a foreseeable time where the restrictions will be lifted. Please remain in compliance with the water restrictions.

Capstone Project:

Mr. Wiggins stated that the Andrew Young School of Policy through GA State University has awarded the City of Forest Park a grant to help us with studies in our Main Street Market Analysis for the use of properties on the Main Street corridor. A select few organizations receive this award.

Mr. Jones stated a more detailed explanation of the project.

Parks Master Plan:

Mr. Wiggins stated that this is Starr Park, an 18 acre park that we are looking to revitalize. We went through an open bid process. Staff has a recommendation for a firm for us to choose, and we will submit that recommendation during the next Mayor & Council meeting to Mayor & Council.

City Hall Renovation: Mr. Wiggins stated that during the month of March to replace the HVAC system and to do a few repairs to our bathroom primarily to bring them into compliance with the Americans with Disabilities Act.

GRM HOF:

Mr. Wiggins stated that they are indeed coming to the City of Forest Park. Target date is April 1, 2017.

MARTA:

Mr. Wiggins stated that MARTA will hold a series of public hearings for proposed changes to bus services. The only meeting that will be held in Clayton County will be at the Clayton County Commission Chambers, Tuesday, January 24, 2017, @ 7pm. There is a proposed change to Route 195 which is Forest Parkway.

Mr. Wiggins stated that MARTA will also host a high capacity transit initiative meeting at our Main St. Community Center. The meeting will be about future expansions involving MARTA, one being rail and larger buses and transit hubs. More information will be forwarded as we receive it.

AN ORDINANCE TO AMEND THE CHARTER OF THE CITY OF FOREST PARK BY REVISING SECTION 4.11 ("CHIEF JUDGE; ASSOCIATE JUDGE") OF ARTICLE IV ("MUNICIPAL COURTS") THEREIN; TO PROVIDE FOR SEVERABILITY; TO REPEAL CONFLICTING ORDINANCES; TO PROVIDE AN ADOPTION DATE; TO PROVIDE AN EFFECTIVE DATE; AND TO PROVIDE FOR OTHER LAWFUL PURPOSES.

WHEREAS, the duly elected governing authority of the City of Forest Park, Georgia (hereinafter the "City") is the Mayor and Council thereof; and

WHEREAS, House Bill 691 was passed by the State of Georgia in 2016; and

**WHEREAS**, House Bill 691 amends Article I of Chapter 32 of Title 36 of the Official Code of Georgia; and

WHEREAS, Article I of said Title and Chapter regulates municipal courts, including but not limited to the appointment and removal of municipal judges; and

WHEREAS, prior to the passage of House Bill 691, Section 36-32-2 of said Article, Title and Chapter provided, that municipal judges served at the pleasure of the municipality's governing authority; and

WHEREAS, House Bill 691 amends Section 36-32-2 of said Article, Title and Chapter to provide that municipal court judges shall serve definite terms and are removable only for cause; and

WHEREAS, the City desires to amend its Charter by home rule ordinance; and

WHEREAS, a synopsis of this ordinance has been advertised once per week for three (3) weeks within sixty (60) days preceding the final adoption of this ordinance, in accordance with Section 36-35-3(b)(1) of the Official Code of Georgia; and

**WHEREAS**, a synopsis of the ordinance was advertised in the Clayton News Daily newspaper on January 25, 2017; February 1, 2017; and February 8, 2017; and

WHEREAS, the notice of the adoption of this ordinance provided that a copy of the proposed ordinance was available for inspection in the Office of the Forest Park City Clerk and the Office of the Clayton County Superior Court Clerk, in accordance with Section 36-35-3(b)(1) of the Official Code of Georgia, and a copy of the proposed ordinance was placed in said locations; and

**WHEREAS**, this ordinance has been considered at two (2) consecutive public meetings, no less than seven (7) and no more than sixty (60) days apart, in accordance with Section 36-35-3(b)(1) of the Official Code of Georgia; and

**WHEREAS**, this ordinance was considered at public meetings held on February 6, 2017 and February 20, 2017; and

WHEREAS, the amendments contained herein would benefit the health, safety, morals and welfare of the citizens of the City.

BE IT AND IT IS HEREBY ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF FOREST PARK, GEORGIA THAT, and by the authority thereof:

Section One. Section 4.11 ("Chief Judge; Associate Judge") of Article IV ("Municipal Court"), of the Charter of the City of Forest Park, Georgia is hereby amended by deleting the existing text and inserting the following text, to read and to be codified as follows:

#### "Sec. 4.11. – Municipal Judges.

- (a) The municipal court shall be presided over by a chief judge and such part-time, full-time, or acting judges as shall be provided by ordinance.
- (b) No person shall be qualified or eligible to serve as a judge on the municipal court unless he or she has met all requirements imposed by state law.
- (c) All judges shall be appointed by mayor and city council pursuant to the method of selection established by ordinance.
- (d) Compensation of the judges shall be fixed by ordinance or resolution of mayor and city council.
- (e) The appointment of any judge to the municipal court shall be of a term of no less than one year. The length of such term shall be established by ordinance, resolution, or written agreement between the judge and the mayor and city council.
- (f) Notwithstanding the duration of the term of the judge, he or she may be removed from office. Such removal shall occur as authorized by state law.
- (g) Notwithstanding the duration of the term of the judge, unless he or she is removed from office or he or she has resigned, he or she shall serve until mayor and city council appoint a successor.
- (h) Before assuming office, each judge shall take an oath, given by the mayor, that he or she will honestly and faithfully discharge the duties of his or her office to the best of his or her ability and without fear, favor, or partiality. The oath shall be entered upon the minutes of the city council journal."

Section Two. The preamble of this Ordinance shall be considered to be and is hereby incorporated by reference as if fully set out herein.

Section Three. This Ordinance shall be codified in a manner consistent with the laws of the State of Georgia and the City.

Section Four. (a) It is hereby declared to be the intention of the Mayor and Council that all sections, paragraphs, sentences, clauses and phrases of this Ordinance are or were, upon their enactment, believed by the Mayor and Council to be fully valid, enforceable and constitutional.

(b) It is hereby declared to be the intention of the Mayor and Council that, to the greatest extent allowed by law, each and every section, paragraph, sentence, clause or phrase of this Ordinance is severable from every other section, paragraph, sentence, clause or phrase of this

Ordinance. It is hereby further declared to be the intention of the Mayor and Council that, to the greatest extent allowed by law, no section, paragraph, sentence, clause or phrase of this

Ordinance is mutually dependent upon any other section, paragraph, sentence, clause or phrase

of this Ordinance.

(c) In the event that any phrase, clause, sentence, paragraph or section of this Ordinance

shall, for any reason whatsoever, be declared invalid, unconstitutional or otherwise

unenforceable by the valid judgment or decree of any court of competent jurisdiction, it is the

express intent of the Mayor and Council that such invalidity, unconstitutionality or

unenforceability shall, to the greatest extent allowed by law, not render invalid, unconstitutional

or otherwise unenforceable any of the remaining phrases, clauses, sentences, paragraphs or

sections of the Ordinance and that, to the greatest extent allowed by law, all remaining phrases,

clauses, sentences, paragraphs and sections of the Ordinance shall remain valid, constitutional,

enforceable, and of full force and effect.

**Section Five.** All ordinances and parts of ordinances in conflict herewith are hereby

expressly repealed.

Section Six. The effective date of this Ordinance shall be the date of adoption unless

otherwise stated herein.

AN ORDINANCE TO AMEND CHAPTER 5 ("MUNICIPAL COURT") OF ARTICLE A ("GENERAL PROVISIONS") OF THE CODE OF ORDINANCES, CITY OF FOREST PARK, GEORGIA, BY AMENDING SECTIONS 2-5-17, 2-5-18, 2-5-18.1, AND 2-5-19; TO PROVIDE FOR SEVERABILITY; TO REPEAL CONFLICTING ORDINANCES; TO PROVIDE AN ADOPTION DATE; TO PROVIDE AN EFFECTIVE DATE; AND TO PROVIDE FOR OTHER LAWFUL PURPOSES.

WHEREAS, the duly elected governing authority of the City of Forest Park, Georgia (hereinafter the "City") is the Mayor and Council thereof; and

WHEREAS, House Bill 691 was passed by the State of Georgia in 2016, and it amended Article I of Chapter 32 of Title 36 of the Official Code of Georgia; and

**WHEREAS**, Article I of said Title and Chapter regulates municipal courts—including but not limited to the appointment and removal of municipal judges; and

WHEREAS, the determined that due to the amendment of state law and as a matter of course, changes to its charter and Code of Ordinances were necessary; and

WHEREAS, the City amended its Code of Ordinances to comply with state law on January 3, 2017; and

**WHEREAS**, the City amended its charter to comply with state law by home rule ordinance adopted February 6, 2017 and February 20, 2017; and

WHEREAS, the City desires to further amend its Code of Ordinances due to such amendments to its charter; and

WHEREAS, the governing authority of the City determines that further amendments to its Code of Ordinances will provide for the health, safety, and welfare of the inhabitants of the City.

### NOW, THEREFORE, BE IT AND IT IS HEREBY ORDAINED BY THE GOVERNING BODY OF THE CITY OF FOREST PARK, GEORGIA THAT:

Section One. Section 2-5-17 ("Method of selection of chief municipal judge, municipal court judge pro tem, and assistant court judge"), of Chapter 5 ("Municipal Court"), of Article A ("General Provisions") of the Code of Ordinances, City of Forest Park, Georgia is hereby amended by deleting the existing text and inserting the following text, in lieu thereof, to read to and to be codified as follows:

"Sec. 2-5-17. – Appointment and duties of municipal court judges.

- (a) The mayor and council may appoint a chief judge to preside over the city's municipal court.
  - (1) The chief judge shall be responsible for the general supervision of the municipal court and shall promulgate all rules necessary for the supervision, conduct, and administration of the court.
  - (2) A member of the governing body shall nominate any qualified person for the office of chief judge, said nomination shall be seconded, and, in the event more than one (1) qualified person is nominated, the person obtaining the vote of the majority of the governing body shall be appointed chief judge.
- (b) The governing body shall also appoint an assistant judge who shall preside over sessions of a division of the municipal court to be known as the environmental division.
  - (1) Said appointment shall follow the same procedure for appointment as that of the chief judge.
- (c) The governing body shall also appoint as many judges pro tempore as it may deem necessary from time to time.
  - (1) Said appointments shall follow the same procedure for appointment as that of the chief judge.
  - (2) Such judges pro tempore shall be acting chief municipal court judge or assistant municipal court judge in the absence, disability or disqualification of such judges.

The judges pro tempore shall have all the powers and perform all the duties of the chief or assistant judge."

<u>Section Two.</u> Section 2-5-18 ("Chief judge"), of Chapter 5 ("Municipal Court"), of Article A ("General Provisions") of the Code of Ordinances, City of Forest Park, Georgia is hereby amended by deleting the existing text and inserting the following text, in lieu thereof, to read to and to be codified as follows:

"Sec. 2-5-18. – Terms of municipal court judges.

Municipal judges shall serve a term of one year, unless modified by written agreement between the governing body and the judges, which agreements shall otherwise comply with state law."

Section Three. Section 2-5-18.1 ("Municipal Court Judge Pro Tem"), of Chapter 5 ("Municipal Court"), of Article A ("General Provisions") of the Code of Ordinances, City of Forest Park, Georgia is hereby amended by repealing its existing text.

Section Four. Section 2-5-19 ("Compensation"), of Chapter 5 ("Municipal Court"), of Article A ("General Provisions") of the Code of Ordinances, City of Forest Park, Georgia is hereby amended by deleting the existing text and inserting the following text, in lieu thereof, to read and to be codified as follows:

"Sec. 2-5-19. – Compensation of municipal court judges.

The amount and frequency of compensation of municipal judges shall be established from time to time by resolution of the governing authority."

**Section Five.** The preamble of this Ordinance shall be considered to be and is hereby incorporated by reference as if fully set out herein.

Section Six. This Ordinance shall be codified in a manner consistent with the laws of the State of Georgia and the City.

AN ORDINANCE TO AMEND THE CODE OF ORDINANCES, CITY OF FOREST PARK, GEORGIA, TO ESTABLISH A DEPARTMENT OF TECHNOLOGY SERVICES BY AMENDING SUBSECTION A OF SECTION 2-3-1 (DEPARTMENTS ESTABLISHED) IN ARTICLE A (GENERAL PROVISIONS) OF CHAPTER 3 (ADMINISTRATION) IN TITLE 2 (GENERAL GOVERNMENT) AND BY ENACTING TITLE 12 (TECHNOLOGY SERVICES) AND CHAPTER 1 (DEPARTMENT OF TECHNOLOGY SERVICES) IN SAID TITLE; TO PROVIDE FOR SEVERABILITY; TO REPEAL CONFLICTING ORDINANCES; TO PROVIDE AN EFFECTIVE DATE; AND FOR OTHER LAWFUL PURPOSES.

WHEREAS, the duly elected governing body of the City of Forest Park, Georgia (the "City") is the Mayor and Council thereof; and

WHEREAS, the administration of the City has become increasingly more dependent upon the use of information technology including, but not limited to, computers and data communication systems, with advancements in, and the prevalence of use of, said technology in recent years; and

WHEREAS, the governing body previously has established various departments of the City in Section 2-3-1 of the Code of Ordinances, City of Forest Park, Georgia (the "Code") but no department presently exists to address exclusively information technology issues; and

WHEREAS, the governing body desires to establish a Department of Technology Services to oversee the planning and the management of the City's increasing use of information technology; and

**WHEREAS**, Section 3.10 of the Charter of the City of Forest Park, Georgia authorizes the governing body to establish, by ordinance, departments of the City; and

**WHEREAS**, the public health, safety, and general welfare of the citizens of the City will be positively impacted by the adoption of this Ordinance.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF FOREST PARK, and by the authority thereof:

Section 1. The Code of Ordinances, City of Forest Park, Georgia is hereby amended by striking the existing text of subsection (a) of Section 2-3-1 ("Departments established") in Article A ("General Provisions") of Chapter 3 ("Administration") in Title 2 ("General Government") and enacting new text in lieu thereof, to read and to be codified as follows:

- "(a) The following departments of the city are hereby established:
  - (1) Police;
  - (2) Finance;
  - (3) Public works;
  - (4) Parks and recreation;
  - (5) Public services;
  - (6) Fire; and
  - (7) Technology services."

<u>Section 2.</u> The Code of Ordinances, City of Forest Park, Georgia is hereby amended by enacting Title 12, to read and to be codified as follows:

"Title 12 - Technology Services"

<u>Section 3.</u> The Code of Ordinances, City of Forest Park, Georgia is hereby amended by enacting Chapter 1 in Title 12 ("Information Technology"), to read and to be codified as follows:

"Chapter 1 – DEPARTMENT OF TECHNOLOGY SERVICES

#### Section 12-1-1. – Department established; purpose; director.

- (1) There is hereby established a department of technology services for the purpose of planning and managing the informational systems and data communications equipment utilized by the City.
- (2) The department of technology services shall be composed of a director who shall oversee said department and such other officer and employees as are

from time to time deemed necessary by the mayor and council. The director of the department of technology services shall be nominated by the city manager with confirmation of such appointment by the governing body in accordance with Section 3.14 of the Charter of the City. The director shall report to the city manager.

## Section 12-1-2. — Duties and responsibilities of the director and department; establishment of rules and regulations.

- (1) Under the direct supervision of the city manager, the director of technology services shall be responsible for the planning and management of the information systems and data communications equipment utilized by the departments, officials, employees and agents of the City. These responsibilities shall include, but are not limited, the following:
  - a) Overseeing the development of the City-wide information and technology strategy;
  - b) Coordinating all telephony, voice, and data equipment and communications to and from the departments, officials, employees and agents of the City;
  - c) Overseeing and maintaining network security of the City's informational systems and data communications equipment;
  - d) Overseeing network and server administration;
  - e) Overseeing application system administration; and
  - f) Providing end-user support to the various departments, officials, employees and agents of the City.
- (2) The director of the department of technology services shall establish such rules and regulations as shall, from time to time, be necessary to the performance of the duties and the functions of the department of technology services pursuant to this Chapter. The director shall recommend to the City Manager for submission to and approval by the governing body any changes which he deems desirable in the provisions of this Chapter, other provisions of the Code of Ordinances or resolutions of the City affecting the department of technology services.

#### Section 12-1-3. - Assignment of additional duties.

In addition the duties as provided in Section 12-1-2, the department of technology services shall perform any and all other duties which be assigned to it by the City Manager, in writing or otherwise, and the department shall have all power and authority necessary to carry out such additional assigned duties."

<u>Section 4.</u> The preamble of this Ordinance shall be considered to be and is hereby incorporated by reference as if fully set out herein.

Section 2. The rezonings indicated in Section 1 are to be noted on the official Zoning Map of the City of Forest Park, Georgia approved by the Mayor and Council as soon as reasonably possible following adoption of this Ordinance, along with an editorial note on the official Zoning Map of the City of Forest Park, Georgia specifying the parcels affected by this Ordinance and the date of the adoption of this Ordinance.

<u>Section 3.</u> The preamble of this Ordinance shall be considered to be and is hereby incorporated by reference as if fully set out herein.

<u>Section 4.</u> (a) It is hereby declared to be the intention of the Mayor and Council that all sections, paragraphs, sentences, clauses and phrases of this Ordinance are or were, upon their enactment, believed by the Mayor and Council to be fully valid, enforceable and constitutional.

(b) It is hereby declared to be the intention of the Mayor and Council that, to the greatest extent allowed by law, each and every section, paragraph, sentence, clause or phrase of this Ordinance is severable from every other section, paragraph, sentence, clause or phrase of this Ordinance. It is hereby further declared to be the intention of the Mayor and Council that, to the greatest extent allowed by law, no section, paragraph, sentence, clause or phrase of this

Ordinance is mutually dependent upon any other section, paragraph, sentence, clause or phrase

of this Ordinance.

(c) In the event that any phrase, clause, sentence, paragraph or section of this Ordinance

shall, for any reason whatsoever, be declared invalid, unconstitutional or otherwise

unenforceable by the valid judgment or decree of any court of competent jurisdiction, it is the

express intent of the Mayor and Council that such invalidity, unconstitutionality or

unenforceability shall, to the greatest extent allowed by law, not render invalid, unconstitutional

or otherwise unenforceable any of the remaining phrases, clauses, sentences, paragraphs or

sections of the Ordinance and that, to the greatest extent allowed by law, all remaining phrases,

clauses, sentences, paragraphs and sections of the Ordinance shall remain valid, constitutional,

enforceable, and of full force and effect.

Section 5. All ordinances and parts of ordinances in conflict herewith are hereby

expressly repealed.

Section 6. This Ordinance shall be codified in a manner consistent with the laws of the

State of Georgia and the City.

Section 7. The effective date of this Ordinance shall be the date of adoption unless

otherwise specified herein.

AN ORDINANCE TO AMEND SECTION 8-8-121 ("ESTABLISHMENT OF BOARD OF APPEALS") OF ARTICLE I ("BOARD OF ZONING APPEALS") OF CHAPTER 8 ("ZONING") IN TITLE 8 ("PLANNING AND DEVELOPMENT") OF THE CODE OF ORDINANCES, CITY OF FOREST PARK, GEORGIA BY REPEALING THE CURRENT LANGUAGE IN SAID SECTION IN ITS ENTIRETY AND ENACTING NEW REGULATIONS IN LIEU THEREOF; TO PROVIDE FOR SEVERABILITY; TO REPEAL CONFLICTING ORDINANCES; TO PROVIDE AN ADOPTION DATE; TO PROVIDE AN EFFECTIVE DATE; AND TO PROVIDE FOR OTHER LAWFUL PURPOSES.

WHEREAS, the duly elected governing body of the City of Forest Park (the "City") is the Mayor and Council thereof; and

WHEREAS, the City has the power to adopt ordinances relating to the administrative officers, bodies, and agencies for the efficient exercise of its zoning power granted by the 1983 Constitution of the State of Georgia, including but not limited to Article IX, Section II, Paragraph IV; the authority granted by the General Assembly of the State of Georgia, including but not limited to O.C.G.A. § 36-66-2; and

WHEREAS, Section 8-8-121 of the Code of Ordinances prohibits Board of Zoning Appeals members from holding any other public office or position in the City; and

WHEREAS, the governing body desires to remove this prohibition in order to improve the management and administration of the Board of Zoning Appeals; and

WHEREAS, the health, safety, and welfare of the citizens of the City will be positively impacted by the adoption of the Ordinance.

# BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF FOREST PARK, GEORGIA, and by the authority thereof:

Section 1. The Code of Ordinances, City of Forest Park, Georgia is hereby amended by striking, in its entirety, the existing text in Section 8-8-121 ("Establishment of Board of Appeals") of Article I ("Board of Zoning Appeals") of Chapter 8 ("Zoning") in Title 8 ("Planning and Development") and inserting the following text in lieu thereof to read and to be codified as follows:

"A board of zoning appeals is hereby established. Said board shall consist of five (5) members appointed by the mayor and council for overlapping terms of not less than three (3) nor more than five (5) years. Any vacancy in the membership shall be filled for the unexpired term in the same manner as the initial appointment. Members will be removed for cause by the appointing authority upon written charges and after public hearing. Members shall be paid an amount that will be fixed from time to time by the governing body by resolution."

<u>Section 2.</u> The preamble of this Ordinance shall be considered to be and is hereby incorporated by reference as if fully set out herein.

Section 3. This Ordinance shall be codified in a manner consistent with the laws of the State of Georgia and the City.

Section 4. (a) It is hereby declared to be the intention of the Mayor and Council that all sections, paragraphs, sentences, clauses and phrases of this Ordinance are or were, upon their enactment, believed by the Mayor and Council to be fully valid, enforceable and constitutional.

(b) It is hereby declared to be the intention of the Mayor and Council that, to the greatest extent allowed by law, each and every section, paragraph, sentence, clause or phrase of this Ordinance is severable from every other section, paragraph, sentence, clause or phrase of this

Ordinance. It is hereby further declared to be the intention of the Mayor and Council that, to the

greatest extent allowed by law, no section, paragraph, sentence, clause or phrase of this

Ordinance is mutually dependent upon any other section, paragraph, sentence, clause or phrase

of this Ordinance.

(c) In the event that any phrase, clause, sentence, paragraph or section of this Ordinance

shall, for any reason whatsoever, be declared invalid, unconstitutional or otherwise

unenforceable by the valid judgment or decree of any court of competent jurisdiction, it is the

express intent of the Mayor and Council that such invalidity, unconstitutionality or

unenforceability shall, to the greatest extent allowed by law, not render invalid, unconstitutional

or otherwise unenforceable any of the remaining phrases, clauses, sentences, paragraphs or

sections of the Ordinance and that, to the greatest extent allowed by law, all remaining phrases,

clauses, sentences, paragraphs and sections of the Ordinance shall remain valid, constitutional,

enforceable, and of full force and effect.

Section 5. All ordinances and parts of ordinances in conflict herewith are hereby

expressly repealed.

Section 6. The effective date of this Ordinance shall be the date of adoption unless

otherwise stated herein.
