BACKGROUND AND SUMMARY: Councilman Smith has proposed to institute a program to acknowledge property owners in Ward 1 who have taken exceptional care of their property by placing a personalized 'Most Beautiful Yard' sign on display of the front lawn of willing participants. The overall goal is to encourage property maintenance and improvements in a manner that promote community pride throughout the entire Ward 1

Community. The awardees will be selected on a quarterly basis by Councilman Smith.

Lefko Development, Inc., DBA Lefko Construction, was the lowest qualified bidder on the project. The resolution is requesting authorization for the Mayor to execute the contract with Lefko Development, Inc., DBA Lefko Construction for the building improvements of the P B & Z Office.

WORK SESSION OF MAYOR AND COUNCIL OF JANUARY 3, 2017

Call to Order: The Work Session of Mayor and Council of January 3, 2016

called to order by Mayor David Lockhart at 6:00 p.m.

Agenda Items: Consider the minutes from the Work Session and the Regular meeting of the Mayor & Council of December 5, 2016.

Ordinance to amend the Code of Ordinances of Forest Park to allow date and time of meetings to be set by Resolution.

Resolution to establish the dates, times, and locations of regular meetings. Mayor Lockhart asked for any discussion. Councilwoman Wells stated that she didn't think it was necessary to take away the time the citizens have to interact with Mayor & Council. Mayor Lockhart stated that we do still have the comment period in place. Councilman Antoine stated that he didn't think it was neither fair nor transparent to you the citizens. Mayor Lockhart asked that Councilman Antoine please direct his comments to the Chair. Councilman Antoine stated that it's a disservice to you all that are in here. Mayor Lockhart asked that Councilman Antoine please direct his comments to the Chair. The Mayor warned Councilman Antoine about speaking out of order. Councilman Antoine asked for a point of order. Attorney Winston Denmark stated that yes, as a point of order, all

comments are to be directed to the Chair. Councilman Mears stated that as he understands it, it is not set in stone, but will fluctuate with the time frame. Councilman Mears also stated that he doesn't want his people in his Ward to wait to the last minute to come to him with problems. Mayor Lockhart stated that for those who do wait, we will always maintain that public comment period so they can speak to us directly and publicly. Councilwoman Wells asked for the Mayor and Council to consider what the citizens want in regard to this change. Councilwoman Bagley stated that, as she understands it, we are not eliminating the public comment period. Mayor Lockhart stated no, we are not taking away the public comment period. Councilman Smith stated that we lose some of our senior citizens during the long duration in between meetings and we would like to prevent that.

Appointment of Election Superintendent. Mayor Lockhart stated that presently Lois Wright is serving and Joan Burton has been serving as the assistant. Councilwoman Wells stated that she feels that Ms. Wright has been doing a great job. Councilwoman Wells stated that she doesn't think it's a good idea to bring someone else in when we have someone who is doing a great job. Mayor Lockhart agreed. Councilwoman Wells asked what the role is of the Assistant Election Superintendent. Mayor Lockhart stated that the exact role would be dictated by the Superintendent. Councilwoman Wells stated that Ms. Wright should be able to choose who her assistant would be. Mayor Lockhart stated that Council has generally appointed the Assistant Superintendent as well. If Council gave Ms. Wright the power to choose her own, then she would have that power. Councilwoman Wells asked for it to be considered so as not to revisit the previous issues. Mayor Lockhart stated that it bears discussion, and he never did get word on resolution. Mr. Wiggins stated that we did establish there was a mishandling of an issue with no malice intent. The police department did investigate to determine if there was any criminal element and they turned the complaint over to the Board of Elections and the Secretary of State. We, including the Police Chief, have not heard anything back from the Secretary of State. Mr. Wiggins stated that the investigation is still underway.

Appointment of Chief Municipal Court Judge and appointment of Assistant Judge Environmental. Mayor Lockhart stated that Judge Ronald Freeman is presently serving for both.

Appointment of Mayor Pro-tem. Mayor Lockhart stated that we have been rotating on an annual basis and Council is free to choose from among yourselves any member that you would like to serve as Mayor Pro-tem. In keeping in that same rotation, Mayor Lockhart stated that it would put the Mayor Pro-tem position to Councilman Antoine. Mayor Lockhart asked Councilman Antoine if he would accept that position. Councilman Antoine accepted the position of Mayor Pro-tem.

Appointment to Urban Redevelopment Agency. Mayor Lockhart stated that he has appointed Naeem Thobhani. The Mayor will ask Council to confirm that appointment.

Proclamation to the family of Mrs. Mary Ann Connelly and to the family of Sgt. Michael H. Earles.

Resolution by the Mayor and Council of the City of Forest Park, Georgia, naming the depositories for funds of the City of Forest Park: authorizing withdrawals of said funds by check or draft: and naming the officers of said city authorized to sign checks or drafts.

Ordinance authorizing temporary loans by the City of Forest Park.

Approval of signage for Councilwoman Wells' Ward 4-Most Beautiful Yard program. Councilwoman Wells stated that we are trying to keep Ward 4 beautiful by picking out a resident quarterly who maintains their yard well. We will place a sign in their yard saying they are the winner of the Keep Ward 4 Beautiful Program. Councilwoman Wells stated that she is hoping that all Wards will participate since we don't have the Keep Forest Park Beautiful Program any longer. Councilman Mears wanted to verify that Councilwoman Wells' name will be on the sign. Mayor Lockhart stated that that is part of the approval process.

Honorary naming of the Community Recreation Building located 803 Forest Parkway. Mayor Lockhart asked Mr. Wiggins if we've ever had a longer serving Director. Mr.

Wiggins stated that he did not. Councilwoman Wells stated that she agreed but didn't want other employees to be overlooked. Councilwoman Bagley stated that The Carl Rhodenizer Center, Rex, Ga, is named as an honor and not a post honorarium. That facility has continued to thrive and to continue to grow and ours can do the same. Councilman Mears stated that he had talked to Mr. Wiggins and Mr. Wiggins stated that this is not uncommon. Councilman Mears stated that it would be an honor that the City could give Ms. Corley that she could enjoy what time she's got left knowing that she is leaving something behind that we can remember her for.

Ordinance that addresses the appointment and removal of Municipal Court Judges. Mayor Lockhart stated that per GA Legislature, we must give them a fixed term of at least a year and this ordinance will accomplish this. The Mayor stated that the assistant judges are not yet covered in this ordinance, so we will need to revisit and amend the ordinance to make it work the way Forest Park courts work.

Resolution authorizing the Mayor to execute an agreement with the Assistant Municipal Court Judge of Environmental Court.

Resolution authorizing the Mayor to enter into an agreement between the Chief Municipal Court Judge and the City of Forest Park.

Resolution authorizing the Mayor to sign a contract between the Development Authority and the City of Forest Park for the leasing of 696 Main Street.

Resolution authorizing the Mayor to sign a sub-lease agreement between the GA Radio Museum and Hall of Fame and the City of Forest Park. Mayor Lockhart stated that this has been revised. Mayor Lockhart stated that he does not want the GA Radio Museum and Hall of Fame to assign that lease to some stranger to us that maybe has nothing to do with the museum, radio or hall of fame. The Mayor stated that he would like to see the lease provision so that they don't have the right to assign it.

Legal Matters:

Mayor Lockhart read a letter from Attorney Steve Fincher stating that this relates to the issue of tax collection on jet fuel. Clayton County stands to lose \$11M+/year. Forest Park's portion is that we stand to lose \$1.2M based on fiscal vear 2016. Mr. Fincher has suggested litigation and it is time sensitive. We need to file suit by no later than January 17th. Mr. Fincher has asked that we join with Clayton Counties and the other cities to bring that litigation. Clayton County, Riverdale, and Love Joy have already signed off on approving their shares of litigation expenses. What our share would be projected is \$14,100. That breakdown is listed on the last page of that letter. When we're looking at losing better than \$1M a year, even though litigation is never a sure thing. Mayor Lockhart stated that it's worth the risk to spend \$14k to save \$1M particularly when the county itself and the other cities are joining in that litigation. Mayor Lockhart asked if there could be a motion to amend the agenda during the regular meeting to add that for discussion and consideration.

City Manager Report:

Mr. Wiggins chose to yield his time to the next Council meeting on January 17th to include updates.
